## **Types of Leave Under AR 600-8-10**

---

Leave is generally defined as an authorized absence from duty for more

than 24 hours, and it is typically charged against a soldier's accrued leave balance. The regulation outlines several distinct categories of leave, each with its own rules and purposes.

### **Ordinary Leave**

Ordinary leave is the most common type of authorized absence. Soldiers accrue 2.5 days of ordinary leave per month, totaling 30 days per year. This leave can be used for vacations, personal

## Emergency Leave

Emergency leave is granted for urgent situations involving immediate family members, such as a death, serious illness, or other critical events. This type of leave is often approved quickly and may be charged to ordinary leave or, in some cases, granted as advance leave. Soldiers

requesting emergency leave

should provide

documentation of the emergency,

such as a Red Cross message or a statement from a medical professional. The regulation emphasizes that emergency leave should be processed as rapidly as possible to get the soldier to their destination without delay.

### **Permissive Temporary Duty (PTDY)**

Permissive Temporary Duty, often called PTDY, is a type of leave that is not charged against a soldier's leave balance. It is typically authorized for

specific purposes, such as house-hunting during a permanent change of station (PCS), attending a job fair, or participating in professional development activities. PTDY is considered a duty status for pay purposes, meaning the soldier continues to receive full pay and allowances.

However, it must be approved in advance and is subject to strict limits, usually not exceeding 10 days for most purposes.

### Convalescent Leave

Convalescent leave is granted to soldiers recovering from a medical condition or surgical

procedure. It is not charged against ordinary leave and is typically authorized by a military medical provider. The purpose of convalescent leave is to allow the soldier adequate time to heal without worrying about leave balances or duty obligations.

leave is properly documented and that the soldier's return to duty is coordinated with medical clearance.

### Advance Leave

In certain circumstances, a soldier may be granted advance leave, which allows them to take time off before it is actually accrued. Advance leave is limited to a maximum of 30 days and must be repaid through future accruals. It is typically reserved for

soldier's leave balance is insufficient. Commanders must carefully consider advance leave requests to ensure the soldier will be able to repay the leave within a reasonable timeframe.

## **Types of Passes Under AR 600-8-10**

Passes are short-term absences, usually less than 24 hours, that are not charged against leave. They are often granted for weekends, holidays, or other

short breaks. The regulation provides for several types of passes, each with different rules and expectations.

### **Regular Pass**

A regular pass is a routine absence from duty, typically granted for weekends or holidays. Soldiers must be within the local area and remain available for recall if necessary.

Regular passes are usually granted by the unit commander or first sergeant and do not require extensive paperwork.

soldiers must still adhere to uniform and conduct standards while on pass, and they are expected to return to duty at the specified time.

### Special Pass

A special pass may be granted for specific occasions, such as a family event, a religious observance, or a personal milestone. Unlike a regular pass, a special pass may allow a soldier to travel beyond the local area, provided they can be reached in case of

Special passes require advance approval from the commander and may be subject to additional conditions, such as providing an itinerary or checking in periodically.

### Liberty Pass

Liberty passes are short, uncharged absences often granted during training or deployment to give soldiers a brief break. They are typically limited to a few hours and may be restricted to the immediate vicinity of the

duty station. Liberty passes help maintain morale and reduce stress during demanding periods, but they are subject to mission requirements and unit policies.

## How to Request Leave or Pass

---

The process for requesting time off under **Army Regulation Leaves and Passes** is straightforward but requires attention to detail. Soldiers should follow

these general steps:

- Determine the type of leave or pass needed based on the purpose and duration of the absence.
- Check your leave balance on your LES to ensure you have sufficient accrued leave for ordinary leave requests.

- Submit the request through your chain of command, allowing sufficient time for approval — typically at least 48 hours for ordinary leave.

Commanders are required to act on leave requests promptly. If a request is denied, the soldier has the right to request an explanation and, in some cases, appeal the decision through the chain of command.

Leave is typically for more than 24 hours; passes are for less than 24 hours.

Soldiers on pass must be available for immediate recall; soldiers on leave may have more flexibility.

- **Documentation:**

Leave requires formal paperwork (DA Form 31); passes often
