What Is a Clinical Laboratory Competency Assessment Form?

according to established protocols. The form typically includes multiple sections that cover technical skills, knowledge of quality control, safety practices, communication abilities, and problem-solving skills. Unlike a generic performance review, a competency assessment is specifically tied to the technical and regulatory requirements of the laboratory environment.

These forms are used during initial orientation after hiring, during annual reviews, and whenever a new test, instrument, or method is introduced. They also serve as a record for external inspectors who need to verify that the lab has a systematic process for ensuring

Key Components of an Effective Competency Assessment Form

To be truly valuable, a competency assessment form must be comprehensive and tailored to the specific demands of the laboratory. Below are the core components

that should be included.

1. Technical Skills and Procedure Competence

This is the heart of the form. It should list the specific tests, instruments, and procedures each employee is expected to perform. For each skill, the form should include space to indicate whether the employee can perform the task independently, requires supervision, or has not yet achieved competence. Examples include: specimen collection, processing, running chemistry panels, performing microscopic examinations, operating hematology analyzers, and conducting microbiological

3. Safety and Infection Control Practices

Safety is paramount in any clinical lab. The form should evaluate knowledge of proper use of personal protective equipment (PPE), handling of biohazardous materials, chemical safety, fire safety, and waste disposal. Observing compliance with standard precautions and the ability to respond to spills or exposures are critical indicators. This component often includes a checklist of safety competencies that

4. Communication and Professional Conduct Skills

Laboratory staff must communicate clearly with colleagues, supervisors, and occasionally with patients or clinicians. The assessment form should include sections on verbal communication, written documentation, and teamwork. Does the employee report critical results in a timely manner? Are they able to document results legibly and according to policy? Professionalism, punctuality, and adherence to ethical standards are also evaluated here.

5. Problem-Solving and Troubleshooting

In a fast-paced lab, unexpected issues arise constantly. The competency form should include a section that assesses the employee's ability to troubleshoot instrument errors, identify specimen integrity problems, and resolve discrepancies. Scenarios or case studies can be used, or the evaluator can note real instances observed during the assessment period.

6. Regulatory and Compliance Knowledge

Every lab employee must be aware of applicable regulations—CLIA, CAP, OSHA, and others. The form may

Tailor to Job Roles

A one-size-fits-all form rarely works. For example, a phlebotomist's form will focus on venipuncture techniques, patient interaction, and specimen labeling, while a molecular technologist's form will emphasize PCR setup, contamination prevention, and data analysis. Create different versions or use a modular approach where core competencies are mandatory and role-specific ones are added as needed.

Observable Criteria

Each competency should be defined in concrete, observable terms. Instead of “has good pipetting skills,” use “correctly sets pipette volume, uses appropriate tip, and dispenses liquid without bubbles.” This reduces subjectivity and makes it easier for different evaluators to reach consistent conclusions.

Incorporate Multiple Evaluation Methods

Competency can be assessed through direct observation, review of work products (e.g., stained slides, completed reports), written exams, simulation exercises, and review of quality indicators (e.g., error

rates). The form should allow the evaluator to note which method was used for each competency, and it often requires that at least two methods be combined for a comprehensive evaluation.

Include Space for Comments and Remediation Plans

When an employee does not meet a competency, the form should have a section to describe the deficiency and outline a remediation plan, including target dates for re-assessment. This turns the form from a simple pass/fail tool into a developmental instrument that supports continuous learning.

Follow Regulatory Guidelines

CLIA regulations, for instance, require that competency assessments be performed at six months after hire and annually thereafter, and that the assessment covers all six key areas defined by CLIA: (1) specimen handling, (2) test performance, (3) result reporting, (4) quality control, (5) instrument maintenance, and (6) safety. Ensure your form explicitly references these areas and provides a clear trail of evidence for inspectors.

Regulatory Standards and Accreditation Requirements

Competency

Assessment Form is deeply intertwined with regulatory compliance. Understanding the expectations of major accrediting bodies will help you build a form that withstands inspection.

CLIA Regulations

Under CLIA, laboratories must document the ongoing competency of testing personnel. The regulations specify that at least twice during the first year of employment and annually thereafter, the laboratory must evaluate and document the performance of all testing personnel. The assessment must include direct observation of routine patient test

monitoring of test results, review of QC records, and other quality indicators. Your form should reflect these requirements.

College of American Pathologists (CAP)

CAP's Laboratory Accreditation Program requires a written competency assessment policy that is followed consistently. CAP inspectors will look for evidence that assessments are performed within required timeframes, that deficiencies are addressed, and that the form includes space for evaluator and employee signatures. Some CAP checklists even list specific elements that must be present in competency

documentation.

ISO 15189

For laboratories seeking ISO 15189 accreditation, the competency assessment process must be even more rigorous. ISO 15189 emphasizes the competence of all personnel who influence the quality of examinations. This includes not just testing staff but also those who handle pre-analytical and post-analytical processes. The form should link to the laboratory's training program and quality objectives, and it should be periodically reviewed for effectiveness.

Track and Trend Data

Use the data from competency forms to identify broader training needs across the laboratory. For example, if multiple staff members show weakness in a particular test method, it may indicate a need for updated procedure manuals or a hands-on workshop. Trend analysis can also help predict where errors might occur and allow proactive corrections.

Common

Challenges and Solutions

Even experienced lab managers face obstacles when implementing competency assessments. Here are some frequent challenges and how to overcome them.

Time Constraints

Competency assessments can be time-consuming, especially in busy labs. Solution: integrate assessments into daily routines by using brief observation periods and leveraging technology such as electronic forms that autofill dates and generate reports. Rotate who is assessed each month to spread the workload.

Subjectivity in Evaluation

Without objective criteria, assessments may vary widely between evaluators. Solution: use detailed behavioral anchors and provide examples. For instance, instead of “good technique,” define “uses aseptic technique consistently, including hand hygiene and proper gloving.”

Resistance from Staff

Some employees view competency assessments as punitive. Solution:

communicate the positive purpose—professional growth, safety, and quality improvement. Involve staff in updating the form to increase buy-in. Recognize those who demonstrate high competence as role models.

Documentation Gaps

Missing signatures, incomplete sections, or lost forms can cause nonconformities during audits. Solution: use a digital system that requires all fields to be filled before submission
