- **Sole**

Proprietorship:

Simple and inexpensive to set up, but you are personally liable for all debts and lawsuits.

- **Limited Liability Company (LLC):**

Offers personal liability protection without the complexity of a corporation. This is a popular choice for small local businesses.

- **Corporation (S-Corp or C-Corp):**

Best suited for businesses that plan to seek venture capital or issue stock. Usually overkill for a small local shop.

Once you have chosen a structure, you will need to register your business

name with your state and local government. You may also need to obtain an Employer Identification Number (EIN) from the IRS, even if you do not have employees. Additionally, check with your city or county about required business licenses, permits, and zoning regulations. A home-based bakery, for example, will have different health code requirements than a brick-and-mortar restaurant.

If a brick-and-mortar lease is too expensive, consider alternative models like a shared retail space (pop-up shops), a food truck, or a mobile service that goes to customers' homes.
