- They are hard and brittle - when you strike an ionic crystal, layers shift, causing like-charged ions to repel and the crystal to shatter.

because the ions are free to move. In solid form, they do not conduct electricity.

The Role of Ionization Energy and Electron Affinity

Your Chapter 7 assessment may ask you to relate ionization energy and electron affinity to the formation of ions. Ionization energy is the energy required to remove an electron from a neutral atom. Metals tend to have low ionization energies, making it easy for them to lose electrons. Nonmetals have high electron affinities, meaning they readily gain

electrons. The overall energy change for forming an ionic compound is usually exothermic, meaning energy is released, which stabilizes the system.

Furthermore, you may need to explain why some elements form multiple ions (like iron, which can form Fe^{2+} or Fe^{3+}). This relates to the transition metals' electron configurations and the relative stability of partially filled d subshells.

Common polyatomic ions you must memorize for the assessment:

- Sulfate (SO_4^{2-})
- Carbonate (CO_3^{2-})
- Phosphate (PO_4^{3-})
- Hydroxide (OH^-)

For example, calcium (Ca^{2+}) and oxygen (O^{2-}) form CaO . But what about aluminum (Al^{3+}) and sulfur (S^{2-})? The formula is Al_2S_3 - two Al^{3+} ions give a total of +6, and three S^{2-} ions give -6. Remember to always reduce subscripts to the simplest whole

When naming ionic compounds, start with the cation name, then the anion name (changing the ending to "-ide" for simple anions). For example, NaBr is sodium bromide. For compounds containing polyatomic ions, just

use the name of the polyatomic ion, e.g., NH_4NO_3 is ammonium nitrate.

Metallic Bonding: The Sea of Electrons Model

Metals are fundamentally different from ionic compounds. In a metallic bond, atoms are packed closely together, and their valence electrons are delocalized, meaning they are free to move throughout the entire structure. This is often described as a "sea of electrons" surrounding positive metal ions. This model explains the characteristic properties of metals.

Lattice Energy and Stability

Lattice energy is the energy released when gaseous ions form one mole of an ionic solid. It is a measure of the strength of the ionic bonds in the lattice. The greater the lattice energy, the more stable the compound. Factors that affect lattice energy include ion charge and ion size. For example, MgO has a higher lattice energy than NaCl because Mg^{2+} and O^{2-} have larger charges and are smaller in size, leading to stronger attractions.

Metallic Bonds and Properties: Deeper Insights
