On the morning of February 26, three dams failed in rapid succession, releasing an estimated 132 million gallons of toxic black water, sludge, and debris into Buffalo Creek Hollow.

The wave reached heights of over 30 feet in some areas and traveled

at speeds exceeding 30 miles per hour. It swept through 17 small communities, including Saunders, Lorado, and Pardee, destroying everything in its path. The disaster killed 125 people, injured more than 1,100, and rendered over 4,000 people homeless. Entire families were wiped out in seconds. Homes, schools, churches, and businesses were obliterated. The survivors emerged into a landscape that looked more like a war zone than an Appalachian hollow.
