personally appears and acknowledges signing the document voluntarily. The notary does not need to swear or affirm the signer.

- **Jurats:** The signer personally appears, signs the document in the notary's presence (or swears to a previous signature), and takes an oath or affirmation that the contents are true. A jurat requires an oath.

- **Copy Certifications:** The notary certifies that a copy of a document is a true and

reproduction of the original. You must understand when this is and is not allowed (e.g., you cannot certify copies of vital records like birth or marriage certificates).

- **Oaths and Affirmations:** Know the difference between an oath (invoking a Supreme Being) and an affirmation (a solemn pledge without religious reference).

Screening and Identification

One of the notary's most important duties is to properly identify

the signer. The exam

will test your knowledge of acceptable forms of identification.

- **Satisfactory Evidence:** This means a current passport, a current driver's license, a current state-issued ID card, or a current U.S. military ID. A driving privilege card is not acceptable.
- **Personal Knowledge:** The notary can also identify a signer based on their personal knowledge of the individual.
- **Credible Witnesses:** If a signer does not have satisfactory evidence, you can use one or

two credible witnesses who personally know the signer and who themselves have satisfactory evidence. The rules for using credible witnesses are specific and heavily tested.

Journal Keeping

Pennsylvania notaries are required to keep a physical or electronic journal of all notarial acts. The exam will test your knowledge of what must be recorded in the journal.
