Enter the expected market risk premium (e.g., 6%) in another cell, say B1. You can also compute it as (Average market return – Risk-free rate) using historical data, but be cautious with backward-looking estimates.

Now apply the CAPM formula. In a new cell, write: **=Rf + Beta * MRP**. For instance, **=A1 + (beta_cell)*B1**. Format the result as a percentage.
