The **Colorado Department of Health Care Policy and Financing** is driven by a clear mission: to improve health care equity, access, and

Health First Colorado (Medicaid)

As the state's Medicaid program, Health First Colorado provides comprehensive medical coverage to eligible low-income individuals and families. This

program covers a wide array of services, including doctor visits, hospital stays, prescription drugs, mental health services, dental care, and long-term services and supports. HCPF works tirelessly to streamline enrollment processes and ensure that eligible residents can access these benefits without unnecessary administrative hurdles. the state.

Child Health Plan Plus (CHP+)

For families who earn too much to qualify for Medicaid but cannot afford private insurance, CHP+ offers a low-cost, high-quality health coverage option. This program covers routine checkups, immunizations, emergency care, and vision and dental services for children and pregnant women. The **Colorado Department of Health Care Policy and Financing** administers CHP+ with a focus on ensuring that no child in Colorado goes without

necessary medical care due to cost. The program operates on a sliding fee scale, making it accessible for working families across the state.

Policy Innovation and Reform Efforts

Beyond administering existing programs, HCPF is a leader in health care policy innovation. The agency regularly explores new models of care delivery and payment to improve quality and reduce costs. Key initiatives include:

traditional fee-for-service models toward payment structures that reward providers for positive health outcomes. This shift incentivizes high-quality, efficient care rather than volume of services.

- **Behavioral Health Integration:** Recognizing the critical link between physical and mental health, the department

has implemented

programs to integrate behavioral health services into primary care settings, ensuring that members receive holistic support for conditions such as depression, anxiety, and substance use disorders.

How HCPF Serves Colorado Communities
