Within those 12 months, you must file a non-provisional application to claim the benefit of the provisional date. The non-provisional application is the formal, complete

application that will be examined by a patent examiner. It includes a detailed specification, claims (which define the boundaries of your protection), drawings, and an abstract. draft these to cover your invention's core novelty while avoiding prior art.

- **Drawings:**

Required if needed to understand the invention. Follow specific formatting rules (black and white, numbered parts, etc.).

- **Abstract:**

A brief summary (150 words or less) to help classify the patent.

File online through the USPTO's Patent Center or using the electronic filing system. Pay the required filing fees

(which vary based on entity size: micro,

small, or large). For those wondering **how to patent a product** on a budget, micro-entity status offers significant fee reductions.

### Step 6: Respond to Office Actions and Examiner Communications

After filing, a patent examiner reviews your application. They will issue an Office Action, which is a written communication indicating rejections, objections, or requirements.

Common reasons for rejection include lack of novelty, obviousness, or unclear claims. Do not be discouraged -

this is a normal part of the process. Your

attorney will draft a response arguing why the rejection is incorrect or amending the claims to overcome the objection.

This back-and-forth can take several months or even years. Persistence is key when learning **how to patent a product**. Each response must be filed within a set deadline, usually three months. ### Costs and Timeline for Patenting a Product

While you wait, you can market your product with "patent pending" status, which offers some deterrent effect against copiers.

Many inventors make errors that can jeopardize their rights. Here are pitfalls to watch for:

- **Public disclosure before filing:**  
In most countries, if you sell, offer for sale, or publicly describe your invention before filing a patent application, you lose your right to patent. The U.S. offers a one-year grace period, but it is risky to rely on it. Always file first.
- **Incomplete or vague descriptions:**

Your patent must teach

someone how to make and use the invention. If the description is insufficient, the application may be rejected or held invalid later.

- **Poorly drafted claims:** Claims that are too narrow may be easy to design around; claims that are too broad may be rejected or invalidated. Balance is crucial.
- **Failing to perform a prior art search:** Without a search, you may unknowingly waste money on an unpatentable

idea.

- **Using online “patent mills” without verification:**

Some low-cost services produce weak applications. Choose a reputable attorney.
