Any security guard currently registered with the New York State Department of State must use the **NYS Security Guard Renewal Form DOS 1246** to renew their license. This applies to all guard classifications, including unarmed guards, armed guards, and those working for private security firms, in-house security departments, or as independent contractors. If you hold an active

registration that is expiring, you must submit this form to continue working.

New York State security guard registrations are valid for two years. The expiration date is printed on your registration card. The state recommends that you begin the renewal process at least 60 to 90 days before your current registration expires. This timeline allows sufficient time for processing, which can take several weeks, especially during peak periods.

Submitting the **NYS Security Guard Renewal Form DOS 1246** early is one

of the most effective ways to ensure continuous employment. If your registration lapses, you cannot legally work as a security guard in New York State until a new registration is issued. Employers are required to verify that all guards have active registrations, and working without one can lead to fines and job loss.

Step-by-Step Guide to Completing Form DOS 1246

Filling out the **NYS Security Guard Renewal Form DOS 1246** is a straightforward process if you take it step by step. Below is a detailed walkthrough to help you avoid common errors.

Step 1: Gather Your Information

Step 3: Enter Your Registration Details

Locate your registration number on your current card and enter it exactly as shown. Include the expiration date. This information helps the Department of State match your renewal to your existing record.

Step 4: Document Your Employment History

List every security guard position you have held during the past two years. For each job, provide the employer's full name, address, and your dates of employment. If you have multiple employers, list them in chronological order. If you have had gaps in employment, there is typically a section where you can explain them. Honesty and completeness are critical here.

Step 5: Confirm Your Training Compliance

New York State requires every security guard to complete 8 hours of annual in-service training each year. On the **NYS Security Guard Renewal Form DOS 1246**, you must certify that you have completed this training. You may need to provide the dates of your training courses and the names of the approved training schools. Keep your training certificates in a safe place, as you may be asked to provide them during an audit.

Step 6: Answer the Disclosure Questions Honestly

The form includes a series of questions about criminal convictions, pending

Failure to disclose required information can result in denial or revocation of your registration.

Step 7: Sign and Notarize the Form

The **NYS Security Guard Renewal Form DOS 1246** must be signed in the presence of a notary public. Do not sign the form before appearing before a notary. The notary will verify your identity and witness your signature. Once notarized, your form is ready for submission.

Required Documentation to Include with Form DOS 1246

- The completed and notarized Form DOS 1246.
- A check or money order for the renewal fee, made payable to the "New York State Department of State." Fees are subject to change, so verify the current amount on the DOS website before mailing.
- A copy of your current security guard registration card (front and back).
- Copies of your 8-hour annual in-service training certificates for the past two years.
- If you are renewing an armed guard registration, additional documentation may be required, such as proof of firearms training and a valid pistol permit.

Where to Submit the Completed Form

Once you have completed and notarized the **NYS Security Guard Renewal Form DOS 1246** and gathered all supporting documents, you must mail the package to the New York State Department of State, Division of Licensing Services. The specific mailing address is printed on the form itself and is also available on the DOS website. As of the latest update, the primary address is:

Fees and Payment Methods

The renewal fee for the **NYS Security Guard Renewal Form DOS 1246** is set by the New York State Department of State. It is typically a modest fee, but it is subject to change. the mail. Personal checks are accepted as long as they are drawn on a U.S. bank and include your printed name and address. Make the check payable exactly as instructed on the form.

Common Mistakes and How to Avoid Them
