He is one of the wealthiest African American executives and has built a global technology solutions provider from the ground up.

- **Roger Ferguson Jr.** (Former CEO, TIAA): Before Duckett, Ferguson led

TIAA for over a decade. He was the first African American to hold the position of Vice Chairman of the Federal Reserve. His leadership was a masterclass in managing complex financial institutions and navigating volatile markets.

- **Calvin Butler** (CEO, Exelon): Butler leads one of the nation's largest utility companies, serving millions of customers. His career has been defined by operational leadership and a strong commitment to community engagement and energy transition.

4. **Navigating Diversity Expectations:** Black CEOs are frequently expected to be the voice of diversity for their entire organization. While many are passionate advocates, this expectation can pigeonhole them and detract from their core business responsibilities.

5. **Media and Public Perception:**

While mentorship is common,

The media narrative around African

American CEOs can sometimes focus more on their race and perceived differences than on their business acumen and strategic successes. This creates an additional layer of noise that leaders must manage.

Leadership Styles and Strategic Impact

Despite these challenges, African American Fortune 500 CEOs have consistently delivered strong performance and brought unique perspectives to corporate strategy. Research suggests that diverse leadership teams are more innovative

and make better decisions. These executives often prioritize:
