A common mnemonic is "Every Good Boy Does Fine." The spaces spell the word FACE. In bass clef, the lines from bottom to top are G, B, D, F, A. Try "Good Boys Do Fine Always." The spaces are A, C, E, G. Understanding Rhythm and Note Durations

Whole Notes, Half Notes, Quarter Notes, and Beyond
